The regular meeting of Community Board 8 was called to order at 7:20 PM by Ms. Nizjoni Granville, Chairperson. She welcomed everyone to the November meeting.

<u>Acceptance of Minutes</u> – The minutes of the last meeting were accepted as written. <u>Correspondence</u> – Community Board 8 newsletter and other information was distributed to the community.

Ms. Granville thanked Pastor Henry for hosting Community Board 8 and invited him to say a few words.

# <u>Calvary Community Church</u> – Pastor Cecil Henry

Pastor Henry welcomed everyone to Calvary and extended an invitation for their annual community Thanksgiving Dinner event which will be held on Saturday, November 17, 2018 at 1575 St. Johns Place, Brooklyn, NY from 12PM to 3PM. The youth will be serving 400 thanksgiving dinners to residents in the community regardless of their background or beliefs. Calvary will also be distributing coats, children's clothing and books. Pastor Henry reminded everyone that Calvary Community Church has been a part of the community for almost 30 years and has become a part of the culture of Crown Heights. He stated that they are proud to partner with Community Board 8 in serving the community.

Ms. Granville thanked Pastor Henry and invited representatives from the NYC Parks Department to give an update on the outdoor fitness area at St. Johns Park.

# NYC Parks Department – Mr. Kevin Borgan, Landscaper

Mr. Borgan gave a brief synopsis of the scope of work currently taking place at St. Johns Park. He stated that the overall goal of the project is to provide outdoor fitness equipment for the community. He also gave an update on St. Johns Recreation Center. Construction is currently underway to repair the HVAC System. They are also resolving all of the underlying plumbing issues within the building.

He thanked Councilmember Cornegy for allocating \$500,000 to make repairs and upgrade the outdoor space. The main plan is to preserve as many trees as possible when installing the outdoor exercise equipment. Approximately 5 trees will be removed in order to install equipment including a double-chest press, leg-lift, triple parallel bars and more. Additional benches will also be included. The entire project is expected to be completed within the next two months.

Ms. Granville thanked Mr. Borgan for the update and invited Ms. Naila Rosario from Brooklyn Public Library to make an announcement.

Brooklyn Public Library - Ms. Naila Rosario, Government Relations & Advocacy Manager

Ms. Rosario announced that input is being gathered from the community regarding the design of the new Brower Park Branch which is being relocated to the Brooklyn Children's Museum. Plans for the design will be discussed on Tuesday, November 13, 2018 at the Brooklyn Children's Museum located at 145 Brooklyn Avenue, Brooklyn, NY at 6:30PM.

Ms. Oton asked if the presentation would be put online for the people who are unable to attend the meeting. Ms. Rosario responded that the information will be accessible online but they are also encouraging people to go to the meeting and give their feedback.

Mr. Staton asked if there was more than one RFP (Request for Proposal) put forth. Ms. Rosario stated that they have spoken to several architects but have not chosen one yet.

Ms. Granville thanked Ms. Rosario for the update and acknowledged Senator Montgomery. She invited her to say a few words.

# Senator Velamanette Montgomery – 25<sup>th</sup> Senatorial District

Senator Montgomery extended her thanks to the community for coming out in large numbers to vote as she was proud to announce that the highest number of votes were in the 25<sup>th</sup> Senate District. She also announced that the Democrats will be the Senate majority as of January 8, 2019. She hopes this will shift the priorities of the community and help to maintain its focus on the need for resources.

Senator Montgomery expressed her support of the relocation of the Brower Park Library Branch to the Brooklyn Children's Museum. # <u>Environment, Sanitation, Transportation Committee (EST)</u> - Mr. Robert Witherwax, Chair & Ms. Irsa Weatherspoon, Vice-Chair

The EST Committee met on Tuesday, October 23, 2018 at Brooklyn Neighborhood Improvement Association (BNIA) located at 465 Sterling Place, Brooklyn, NY at 6:30PM. In addition to the Chair and Vice-Chair, present were: Desmond Atkins, Isaac Blasenstein, Janet Collins, Ainslee Dublin-Scott, Alan Gerber, Xeerxeema Jordan, Frances Langley, Robert LaPointe, Meredith Staton, Edison Stewart, Mark Thurton, Deborah Young, and Scott Stern.

The Committee discussed the "Fast Forward: The Plan to Modernize New York City Transit" event that was held in September. The event was a community conversation featuring the President of NYC Transit, Andy Byford. At the event it was discussed that MTA is proposing to install a modern switching system on 5 high-traffic subway lines,

upgrading 150 stations, upgrading 50 stations to make them ADA Accessible, and purchasing 650 new subway cars. The MTA is also proposing to redesign the bus routes for all five boroughs of New York City.

The committee also discussed the hot spot issues concerning the B45 Bus. Some of the suggestions were to eliminate parking on one side of St. Johns Place, establishing delivery times, making St. Johns Place a one way street, re-routing the B45 westbound onto Sterling Place between New York and Rogers Avenues, re-routing the B45 eastbound onto Eastern Parkway from Bedford to New York Avenues, and demanding appropriate traffic enforcement.

Mr. Witherwax stated that they will continue this conversation at next month's meeting. Hopefully the committee can agree on the language so that the item can be presented to the full Board in December. He also stated that the city has agreed to roll back the clear curb initiative along Flatbush Avenue.

# 1. Application LPC-19-27544 for CoA for 907 St Marks Ave (Crown Heights North Historic District)

Nashat Ibrahim, R.A. of NMI Architecture, PLLC, presented owner, Eddie Soleyman's plans to restore 907 St Marks Ave. (B/L: 1223/5) at the NE corner with Kingston Ave. The application is to renovate this four-story Renaissance Revival style flats building designed by Frank S. Lowe and built c. 1908. The plan will create an atgrade entrance. The first two floors of the building were most recently used as a medical arts facility. The two upper floors have been boarded up and vacant for some years.

The plans include:

- the installation of an elevator to make the first floor and basement ADA-accessible;
- making each floor a co-living apartment with seven bedrooms and four bathrooms with a projected monthly rental rate of \$9,000 (or approximately \$1,200/mo. per person);
- replacing the windows and doors;
- adding a door to the rooftop bulkhead; and
- replacing the rear stairs and painting the main stoop.

A motion made by Mr. Veconi and seconded by Mr. Puca, to support the application failed with seven voting no, and two yes, with one abstention. The presentation lacked specifics on the treatments for the façade elements: the type of wood for the windows, paint colors for the various elements including wall masonry and stoop; and proofs that the neighbors have been notified of the project, among other open questions. The owner indicated that proofs of notice have been provided to the Community Board 8 Office. Due to the lack of information on how the proposed work will fit with the existing building's character and the surrounding streetscape, on motion made by Ms. Young and seconded by Ms. Wedderburn, the committee voted nine to one to table the item to allow a review by the Crown Heights North Association since there had not been any outreach by the proponents to the Association as instructed by both LPC and the CB 8 Office. Although the LPC (Landmarks Preservation Commission) hearing for this item is scheduled for 11/20/18, the owner agreed to return to the Land Use Committee on 12/6/18 with the missing information.

# PUBLIC HEARING Capital and Expense Budget Requests for FY 2020 Community Board No. 8 Calvary Community Church 1575 Johns Place Brooklyn, New York 11213

#### November 8, 2018

Ms. Granville called the Public Hearing on the prioritization of the Capital and Expense Budget for FY 2020 to order at 8:30PM. She reminded everyone that the items were submitted to them in advance and the District office had asked that each person submit their top five Capital and top five Expense priorities to the Board. She asked Ms. Tyus and Mr. Witherwax to read the items. The purpose of the public hearing is to help formulate the priorities for up to 40 capital and 25 expense budget requests. The Expense Budget funds current city government services, including the salaries of government employees, pensions, debt service, and routine operating expenses. Expense items are ongoing, reusable items that are needed for daily maintenance of services. The Capital Budget is a separate budget covering one fiscal year, funding physical infrastructure used either in support of government operations (such as government offices, schools, and fire stations) or for general public use (such as roads, bridges, libraries, and parks). To be included in the Capital Budget, individual projects must have a value of at least \$35,000 and a period of probable usefulness of at least five years.

Ms. Wedderburn: In addition to the Expense Item for Healthcare and Human Services, she suggests that funding be allocated for vaccine awareness services and vaccinations for different age groups. Vaccine types should include but not be limited to shingles, HPV, meningitis and measles.

Mr. Ellis: Suggested that the language be tailored to address specific issues in Community Board 8. The information should be provided in a series of classes to target the Community Board 8 population specifically. There is something missing in the language.

Ms. Neale clarified that the budget is a 60 page document and that the Capital & Expense list that he is referring to is just a truncated version of the budget document that will be submitted. The full version which is specific to Community Board 8 can be accessed on the Community Board website at <u>www.brooklyncb8.org</u>.

Mr. Witherwax: Recommended 5 Expense and 3 Capital items related to Environment, Sanitation and Transportation. He listed them in order of priority. The Expense Item suggestions were to: Reinstate the B71 bus line, provide more trash removal and cleanliness in playgrounds, provide greater services to reduce the rodent population in New York City, provide more frequent litter basket collection throughout the district, and increase the budget for Community Boards citywide.

The Capital Item suggestions were to: repair or upgrade the subway stations and other transit infrastructures, specifically the Franklin Avenue Shuttle Station, provide NYPD parking facilities for the 77<sup>th</sup> and 78<sup>th</sup> precincts, and acquire land or a city-owned building for use by Community Board 8.

Ms. Andrews: Commented on the item that referenced a dog run being placed at Brower Park. She stated that Brower Park is unable to acquire a dog run because they do not have enough land for one to be placed there. She asked that this particular item be removed or be altered to request a dog run be placed at Lincoln Terrace Park instead.

Mr. Atkins: Requested additional enforcement from Sanitation on primary and secondary avenues during peak hours citywide.

Ms. Ahuja: In reference to policing and crime, funding needs to be allocated for crime prevention services such as alternative programs for youth and anti-violence programs.

Mr. Ellis: Would like to prioritize the frequency of litter basket collection and enforcement. Would also like to prioritize the expansion of food and hospitality programs that assist low income and homeless families. Also, would like to prioritize the acquisition of land or the re-appropriation of it so that it would be of more use to the community.

Wedderburn: In reference to services regarding child welfare or housing, would like to request that services or referrals be provided to subsidized households where the dwelling is owned by or rented by persons over the age of 55 years old.

Community Resident: Requested that funds be allocated toward the refurbishment of the Richmond Barte sculpture and wall mural at Kingsborough Houses. Would also like to request the installation of lights and proper signage there as well.

Community Resident: State that they are in support of the housing needs and protection programs suggested by the Board. Would like to prioritize the implementation of programs for low income families.

Ms. Tyus: Would like to reiterate the capital request to acquire land for Community Board 8. This is especially important so that committees who won't have to look for facilities to host their meetings or forums.

Ms. Weatherspoon: Requested additional street lights be installed due to increased vegetation over the last few years.

Community Resident: Requested the prioritization of the item referring to educating tenants about their rights and laws pertaining to housing.

Ms. Gibbs: Requested the prioritization of services to reduce the rodent population.

Community Resident: Stated that they support the initiative to address illegal conversions and uses of buildings.

After testimonies were given of what community residents would like to see funded. Ms. Tyus made a motion that the full board vote on the final submission of the budget document and give the District office the authority to use the information gathered at tonight's public hearing and submissions submitted to the office via email and mail to prioritize the top 40 capital and top 25 expense items. The motion was seconded by Ms. Wedderburn and passed with a vote of 32 in favor, none against and none opposed.
