Michelle George, District Manager Julia Neale, Community Coordinator Ms. Irsa Weatherspoon, Chairperson welcomed everyone to the February general meeting of Community Board 8 and called the meeting to order at 6:20 p.m. She thanked everyone for their patience as District office staff resolved technical issues with the Webex meeting link.

She asked for a motion to accept the January minutes. Ms. George stated that one correction was called into the district office from the Seniors Committee. Ms. Muhammad moved that the full board accept the January minutes with the necessary corrections. The motion was seconded by Mr. Mikelsteins and accepted unanimously.

Chairperson Weatherspoon then asked for a roll call. After establishing that a quorum was present. She opened the floor to elected officials, elected official representatives, agency liaisons and public comments.

Ms. Weatherspoon asked Senator Jabari Brisport to say a few words.

# Senator Jabari Brisport – 25<sup>th</sup> Senatorial District

Senator Brisport announced that the suspension of Open Meetings Law has an open ended date for when the suspension will be lifted. Instead of having a hard and fixed date for the end that would have to be extended, it will now end only when the governor declares the Covid State of Emergency over.

The Legislative body voted for and approved the proposed redistricting maps, and the new lines will be voted on in June. Congressional lines are changing significantly and Prospect Heights will now be represented by Jerry Nadler and Bobby Carroll. The Senate dividing line will be Atlantic Avenue. If you live in an area where your electeds will change due to the line changes, your current electeds will remain your electeds until December 31<sup>st</sup>, as the new lines go into effect on January 1<sup>st</sup>.

New York State budget negotiations are underway for the budget that is due on April 1<sup>st</sup>. By February 17<sup>th</sup>, all Assembly and Senate members need to submit their "big ticket" items and funding for discretionary items. Applications for discretionary funds are due by February 13<sup>th</sup>. The Senator stated that FAQs for discretionary funds are available on his website, he is accepting applications thru Sunday.

Ms. Weatherspoon thanked Senator Brisport for the update and invited Assemblywoman Phara Souffrant-Forrest to say a few words.

# Assemblywoman Phara Souffrant-Forrest – 57<sup>th</sup> Assembly District

Assemblywoman Souffrant-Forrest offered greetings to everyone and stated that Senator Brisport has covered all of her key points. She believes that the budget should really be community driven. She would like to hear from the community. She also encouraged all community members and neighborhood organizations seeking discretionary funds to please submit their applications for consideration as soon as possible.

Ms. Weatherspoon thanked Assemblywoman Souffrant-Forrest and invited Assemblywoman Zinerman to say a few words.

# Assemblywoman Stefani Zinerman – 56<sup>th</sup> Assembly District

Assemblywoman Zinerman stated that her office is currently getting ready for March, which is Disability Awareness Month. They are planning an inclusion event and in preparation, are creating a coalition on disabilities experts. This coalition needs members, so please consider joining and participating and being a voice for those that are sometimes voiceless.

Recently proposed in Assembly is an E-Bike Battery Bill. As a sponsor of the bill, the Assemblywoman stated that while she finds e-bikes to be a valuable transportation alternative, there are sometimes difficulties with finding adequate charging stations. There have been 173 fires caused by e-bike charging with 7 fatalities. The legislation requires that retailers must give guidance in 7 common languages, making sure that warnings are legible and visible in an understandable font. Additionally, we need to make sure that landlords provide riders with guidance about charging e-bike batteries. She stressed that this legislation is not an anti e-bike bill, but rather one that encourages operating e-bikes safely and without risk of unnecessarily causing damage to the home.

In honor of Black History Month, her office is putting together a "video love letter" to the black community. If you would like to participate, send a short video of 45 seconds or less about what you love about being black. The theme for black history month this year is black health and wellness. # Councilwoman Darlene Mealy- 41st Council District

Councilwoman Mealy announced that she is back in the City Council after sitting out one term. She stated that her district office is open and ready to serve the community. They are located at 400 Rockaway Avenue between Pitkin and East New York Avenues.

Councilwoman Mealy stated that her office hosts a food pantry and PPE giveaway every Wednesday from 11 am to 2pm at her district office. Fresh and non-perishable foods, as well as face coverings and Covid-19 testing kits will be available for distribution. On Wednesday, February 16, 2022, Borough President Antonio Reynoso will be on hand to assist with the giveaway.

# <u>District Leader Edu Hermelyn</u> – 43<sup>rd</sup> Assembly District

Black History Month – Weeksville played an important part in Brooklyn, in the 1800 it was the first black community in Crown Heights. In 1855, over 520 free African Americans lived in Weeksville including some abolitionists and prominent black professionals. The homes were called Hunterfly Road Houses. The current Weeksville Heritage Center is named after James Weeks. The original Hunterfly Road Homes (which have been renovated) are next to the Weeksville Heritage Center which offers tours of the Hunterfly Road Homes. Chair Gail Branch-Muhammad will have Community Board 8 mail out the brochure to the seniors.

He reminded everyone to be aware of their surroundings at all times because crime is on the rise throughout the city.

The committee heard presentations from Mr. Kevin Smith, Executive Director and Co-Founder of Families and Friends of the Wrongfully Convicted. Several representatives from Homeland Security spoke on human trafficking and Assistant District Attorney Joseph Bianco answered about 15 questions from the community. Police Officer Vidal from Crime Prevention gave a brief update from the 77<sup>th</sup> Precinct.

#### <u>Housing (Advocacy)</u> – Nizjoni Granville, Acting Chair

Ms. Granville reported that the Housing Advocacy Committee met virtually on Wednesday, February 9, 2021 via Webex. The committee discussed the difficulty people are experiencing getting through to various city offices for help. It was stated that some of the issues are due to Covid and the transition of the newly elected

administration. Ms. Robinson former Councilmatic Aide advised the committee to reach out to their local elected officials who may be able to assist by navigating through the red tape.

The committee discussed creating a handbook with helpful information for tenants. They also discussed utilizing the worst landlords list created by Attorney General James to reach out to the owners expressing the concerns and conditions that tenants are experiencing. Also reach out to the tenants to let them know that we are aware of their problems and would like to keep up with their cases and assist in any way.

#### **Environment, Sanitation and Transportation** – Robert Witherwax, Chair

Mr. Witherwax reported that the Environment, Sanitation & Transportation (EST) committee met virtually on Tuesday, January 25, 2022 via WebEx. He stated that the committee is booming with 25 members and they can always use more. If you are concerned about the environment, sanitation or transportation issues come out and join us. At the next meeting on Tuesday, February 22, 2022, the committee will hear reports from the sub-committees who are hard at work exploring topics and issues like rats, illegal dumping, sanitation protocols, rules of the road, additional ADA compliant subway stations, and the stop the chop helicopter movement. All are welcomed to attend.

Ms. Tyus asked for the sub-committee meeting dates. Mr. Witherwax stated that he did not have them handy but will get them to her. Ms. Collins asked what has been done so far with the sub-committees. He stated that the committees are working on draft letters.

#### **Economic Development** – Brian Saunders, Chair

Mr. Saunders reported that the Economic Development Committee met virtually on February 8, 2022 via WebEx. In addition to the Chair, Brian Saunders, present were: Drew Gabriel, Secretary, Celene Rosado, Lisa Atkinson, Kalvis Mikelsteins, Emma Goodman, Garrett Smith, L. Kim Robinson, Karen Gray, Mark Thurton, Sunny Jo and Yahya Raji and submitted the following report:

Mr. Kalvis Mikelsteins attended a webinar hosted by CAMBA on small business services and provided the following information. New York State Small Business Recovery Grant from CAMBA Webinar Jan 25, 2022. This is not the resilience grant, this is a new grant. 800M available, \$400M given out already. These grants do not have to be paid back.

#### Eligibility requirements:

- In business since 2019
- Show a gross receipt from 2019 between \$25K and \$2.5M

- Receiving pandemic unemployment assistance adds to your gross receipt
- Strictly enforced limits (anecdotally by presenter; someone they know made \$24,960 and was denied)
- Have to claim profit (at least 1\$)
- Must Show loss of 25% or more in 2020 pandemic

#### Also:

- Sole proprietors qualify with their social
- Owners can apply for multiple businesses they own

# Other Grant Implications:

- PPP: If you got less than \$250K or more, you do qualify
- EIDL: if you received \$10K or less, you do qualify
- EIDIL supplemental grant: If you received \$5K or less, you do qualify
- If you received the SBA Shuttered venue operator grant you do not qualify

#### Qualifying Amounts:

\$25,000-\$49,000- receive \$5,000

\$50k-\$99k- receive \$10,000

\$100,000-\$2.5M-receive 10% of your gross, but not exceeding \$50,000

Use 2019 gross receipts to determine the amount

Can be used for payroll, past dude expenses, local taxes, insurance costs, utility costs, PPE, HVAC, equipment, machinery, supplies necessary to follow COVID Protocols, rent, mortgage, \*\*\*No prepayment \*\*\* (This is much more flexible than PPP, which was entirely just for payroll)

- Certificate of organization
- Certificate of assumed name (DBA)
- Articles of Incorporation
- NYS municipality issued document showing authorization to operate in NYS

Emma Goodman, Sunny Jo and Garret Smith, a part of The Clean Slate NY campaign provided an overview of the work they are doing. The Clean Slate NY campaign is fighting for a new law (\$1553A/A6399) that will automatically clear a New Yorker's conviction record once they become eligible. The civil damage a conviction record can inflict is often wide-ranging and enduring—permanently barring many individuals from basic opportunities like stable jobs, licenses to practice trades, and safe, secure housing. Clean Slate NY is about strengthening our communities by ensuring that New Yorkers are not punished beyond their sentences and can be full and fair participants in economic and civic life. https://www.cleanslateny.org/steering-committee

In the Q&A portion of the presentation Celene (from Sweet Brooklyn) asked if there would be new language for job applications for employers if this legislation passes. Emma Goodman responded that there are already laws in place that do not allow employers to ask criminal past questions. Drew asked how we as a community board can support the campaign? Sunny Jo provided the steering committee link and a template for a sign on letter.

They announced a Clean Slate event February 27th at Brooklyn commons. Lisa Atkinson asked who qualifies for this event. Sunny Jo explained that anyone with a misdemeanor after 3 years past and a felony after 7 years has passed qualifies to participate in the event.

The next meeting of the Economic Development Committee will be held on Tuesday, March 8, 2022. Mr. Saunders invited everyone to attend and bring one person with you.

Mr. Veconi noted that Transportation Alternatives publicly floated a plan for Atlantic Avenue without meeting with CB8. The EST committee will invite Transportation Alternatives to a future meeting.

The next meeting of the Land Use Committee will be held on Thursday, March 3, 2022. All are welcomed to attend.

The committee heard a very informative presentation from Dr. Augenbraun from Kings County Hospital Infectious Diseases unit. He stated that he has been a physician for 30 years. He started his career at Kings County during the height of the AIDS pandemic and he will end his career with the Covid 19 pandemic. He discussed the various infectious diseases and all things Covid.

Ms. Gibbs mentioned that the Fire Department has confirmed their attendance for the February 17, 2022 meeting to discuss fire safety. All are welcomed to attend and to bring a friend.

Ms. Granville stated that she attended the Veterans Committee meeting of Community Board 3. They are in the process of planning the next veterans parade which will be held on the Saturday before Veteran's day.

Ms. Weatherspoon thanked everyone for their committee reports. She reminded committee chairs to submit committee reports/minutes to the district office immediately after their meeting is held.

She asked if anyone had any questions, comments or announcements.

**Ms. Karen Chambers** from Kings County District Attorney Eric Gonzales's office announced that the DA will be hosting his annual Black History Month celebration on February 22<sup>nd</sup>. While there is no flyer yet, one will be sent to the district office for distribution.

Ms. Weatherspoon thanked those that provided announcements and opened the floor for old business/new business.

Regarding Old Business, Mr. Kwasi Mensah followed up on his request from the previous month about television and radio commercial PSAs about closing the door behind you in a fire. Ms. Henry responded stating that information is being distributed as she received in the mail a New York City Apartment Building Emergency Preparedness guide which is she finds really helpful if you live in an apartment building. Mr. Mensah reiterated that it is imperative to have radio and television adverts as it is easy for people to ignore print but not necessarily radio and television.

Ms. Petula Hanley from Assemblywoman Zinerman's office stated that on behalf of the Assemblywoman, she has attended quite a few meetings about fire safety, and thus recognizes that the FDNY is doing its best to get the word out about fire safety. She also stated that Assemblywoman Zinerman hosted a Fire Safety Zoom last week. Mr. Mensah repeated that the reliance on people to attend

meetings does not outweigh the reach of radio and television adverts.

Ms. Ferris also stated that she has received flyers from her management regarding fire safety.

Ms. Gibbs announced again that the next Health Committee meeting which will be held next week will have a full presentation from the FDNY regarding fire safety. She urged everyone to attend.

Ms. Muhammad asked for any council updates on today's hearings regarding Open Restaurants. Ms. Tyus stated that she heard it was approved. Mr. Todd stated that wood structures have to be removed so that streets can be cleaned at night.

Mr. Jonathan Marable from the Brooklyn Chamber of Commerce stated that New York City is offering a small business grant, the NYC Small Business Resilience Grant, to businesses negatively impacted by the COVID-19 pandemic. Eligible businesses can receive \$10,000 to help with expenses such as payroll and benefits, mortgage, rent, utilities, and other operating costs. Ms. Muhammad asked if anyone was on the meeting from 920 Park Place. Ms. Tyus stated that a number of parking violations, using open space on roadway for staff rather than open space on property. Substantial concerns of damage to street trees due to lax protection. Neighbors still considering legal action via article 78.

Chair Weatherspoon stated that District Manager George has reached out to the Site Manager, Lance Franklin to schedule a community meeting to discuss the community concerns. We are awaiting a response. Ms. Tyus asked if the local neighbors will be allowed to attend. Ms. Weatherspoon stated yes, the community will be invited.

Under New Business, Mr. Arnold Gore, a community resident, read a letter documenting his dissatisfaction with proliferation of smart meters, which relies on wifi internet that exposes people to health effects from radio waves. There is an opt-out clause against a smart meter, but utilities may charge a fee. The preference is moving away from a default opt-out and rather adopting an "opt-in." This legislation has been sponsored by Kevin Parker. Additionally, Mr. Gore stated that there are better alternatives to smart meters and wireless technology in general. While wireless is convenient, it is slower and less safe due to its easy ability to be hacked, and also due to the residual damage the wireless can do to the human body and mind.

Mr. Atkins responded to Mr. Gore's grievances and stated that the concerns sound very familiar to the fight against 5G, and announced that Mr. Gore raised several very valid points. He agreed that wireless technology and smart appliances are very intrusive things, but sadly, there is not enough public outcry to stop it.

Ms. Collins asked are these the meters that Con Edison wants to install in our homes. Mr. Gore replied yes, many people overlook the Con Edison request to opt out until it is too late.

Lastly, Mr. Gore stated that the very high intensity of the pulsed wave fields from smart meters is documented in this video on the website of newyorkers4wiredtech.com/media

Ms. Weatherspoon thanked Mr. Gore for the information. With no further issues to be addressed, the meeting was adjourned at 7:50 pm

She then asked if there was any old business to finish up or any new business. Hearing none, she thanked everyone for attending and adjourned the meeting at 8:00 p.m.
