Ms. Irsa Weatherspoon, Chairperson welcomed everyone to the March general meeting of Community Board 8 and called the meeting to order at 6:20 p.m.

She asked for a motion to accept the February minutes. Mr. Saunders moved, that the full board accept the February minutes with any necessary corrections. The motion was seconded by Ms. Lazar and accepted unanimously.

Chairperson Weatherspoon then asked for a roll call. After establishing that a quorum was present. She opened the floor to elected officials, elected official representatives, agency liaisons and public comments.

Chairperson Weatherspoon acknowledged the elected officials present and invited Councilmember Chi Ossé to say a few words.

## <u>Councilmember Chi Osse</u> – 36<sup>th</sup> Council District

Councilmember Ossé announced that he still hosting Wellness Wednesdays at Restoration Plaza from 11 AM to 1 PM or whenever supplies run out. Vendors are welcomed as are volunteers, and if you want a table to distribute information or desire to volunteer, please call his office at 717-919-0742.

He also announced that as the Chairperson of the Cultural Affairs and International Affairs Committee, he will be seeking to partner with libraries on book giveaways and other culturally related events. These events will occur as the weather gets warmer.

The Councilmember informed the Board that he introduced a bipartisan bill with a Republican cosponsor that would require nightlife establishment operators to train in giving Narcan shots and keep it in stock with their first aid kits. He explained that Narcan is a drug used on victims of overdose to save their lives, and consequently, this bill will go a long way in preventing opioid overdose deaths. He concluded that it is a bill designed to save lives, and hence the bipartisan support.

Sadly, over the last 10 weeks, greater than 95% of constituent concerns have been pertaining to housing. The issues range anywhere from negligent landlords to predatory real estate brokers involved in deed theft. As such, his office will be hosting housing attorneys beginning in April to answer constituent questions about their housing issues. Attorneys will be from CUNY and Churches United for Fair Housing.

On his birthday, March 18th, there will be a Fire Safety event at Restoration Plaza located at 1368 Fulton Street on the 3rd Floor, held in conjunction with Assemblymember Stefani Zinerman. Councilmember Ossé informed the Board that the fire safety event is the first item in a comprehensive fire response plan currently being devised by his office. The plan includes synthesizing fire investigation reports and correlating data from other agencies across the city.

The Councilmember announced that in preparation of tax season, his office is hosting a virtual Tax Workshop on March 28th for tax season. The workshop, which occurs 3 weeks before the tax deadline, will inform filers of changes to tax laws for working individuals. Finally, in partnership with the NYC Department of Health and Mental Hygiene, his office will be hosting a series of rat academies for businesses and residents alike to learn how to be better neighbors with each other, and also to reduce the rodent population.

Chairperson Weatherspoon thanked Councilmember Ossé for his detailed report and stated that she recently contacted the District Attorney's office with regards to fraud and theft, and that she would be in contact with his office as well. She then opened the floor to elected officials representatives.

**Mr. Andrew Wright** from Councilmember Crystal Hudson's office announced that the Councilmember's office recently hosted NYS Governor Kathy Hochul for a walking tour of Vanderbilt Avenue businesses. Merchants discussed many of the issues they faced during the Covid-19 Pandemic, and some that they continue to experience present day. Additionally, the Councilmember visited St. Francis College about the guns for grants program, which allows people to go to college for free if they submit a gun.

The Councilmember recently held a meeting with the Commissioner of the Department of Transportation to discuss the closure of Willoughby Avenue Open Streets. During the meeting, it was announced that DOT will sponsor weeks long survey to gather feedback on open streets, and the Councilmember's office volunteered to oversee distribution of the survey to ensure that it reaches a wide array of people, including those that might not have access to google forms or online surveys.

As a result of the meeting and the community discord over a popular Open Streets being ended without community input, Councilmember Hudson is presently working on a bill that would require notification of the Councilmember, affected Community Board, and other local community organizations about any changes to Open Streets.

Mr. Wright also announced that the Councilmember is seeking suggestions to place 50 garbage cans throughout the 35th Council District. Please submit specific locations on busy commercial corridors for review. All responses will be due by April 8, 2022.

Finally, on March 22nd, the Councilmember will host an info session on dog runs in response to the interest and the number of requests from community residents in CB8. The session will focus on requirements to install one, the definition of a dog run, what a "Friends" group is and how to start one amongst other things.

Ms. Petula Hanley from Assemblymember Stefani Zinerman's office wished all of the phenomenal women on the meeting a Happy Women' month. She announced that it is a busy time of the year for the Legislature as the state legislatives work to pass a fair budget. NYS Governor Kathy Hochul recently held a meeting at Therapy One Bar in Bed Stuy to discuss some of the changes within the NYS Liquor Authority. These changes will directly affect downstate liquor license holders.

Ms. Hanley reiterated the Fire Safety event being held in conjunction with Councilmember Ossé. She stated that this event has come at a time when the 56th Assembly District has never seen so many deadly fires in such a short span of time. There have been greater than 11 fires from January 1st to present day, including three fatalities, and possibly five depending on the cause of death for two additional fatalities. Consequently, the goal is to educate as many individuals as possible to prevent deadly fires. All are encouraged to participate in the session and share information.

On Saturday, March 26th at 11 AM, Disability Advocacy Day will be held at Boys and Girls High School. At this event, the goal is to dissect the needs of those with disabilities in terms of transportation, access, education, etc. Additionally, we cannot forget those with invisible disabilities. Everyone is encouraged to attend.

Mr. Orlando Ross from Congresswoman Yvette Clarke's office announced that the previous day,

Congresswoman Clarke was able to secure \$17 million for community projects in the 9th Congressional District. Projects to be funded include many related to matters of health including funds for the Cure Violence Center in Brownsville, the Brooklyn Museum of Art, and Interfaith Medical Center.

**Mr. Justin Freeman** from Assemblymember Phara Souffrant-Forest's office announced that the Assemblymember is assisting with finalizing the Assembly House Budget to be presented to the Governor. The Assembly's budget will likely include a few of Assemblywoman Souffrant's top priorities, including fair pay for homecare workers.

On March 19th, volunteers will perform on an outreach canvas in the community to see who needs help. One group of volunteers will knock on doors and speak to constituents, and another group of volunteers will be on the back end working to help resolve constituent cases. There have been several other canvasses in recent months and they have been impactful, especially in determining that housing concerns are some of the biggest issues that people have been contending with as espoused by Councilmember Ossé. So far, the canvasses have been successful in connecting people to the Department of Housing Preservation and Development, building tenants association, building collective community power, etc.

**Mr. Tony Herbert** announced that he has been appointed as the Brooklyn North Director of the Mayor's Office Community Assistance Unit (CAU). He stated that he and Mr. McDaniel will be working closely together to help handle CB8's issues. Mr. Herbert stated that he is no stranger to CB8, briefly listing many of the Board's officials and some of the ways he has worked with them in the past. In fact, he lived in the district for many decades and still owns property here. Finally, he looks forward to "coming back home" so to speak, and bringing with him when he comes important news and efforts on the mayoral front.

**Mr. Jack Plushnick** from Councilwoman Darlene Mealy's office extended greetings on behalf of the Councilwoman. He announced that the office holds weekly food and PPE distributions every Wednesday from 10 AM to 1 PM or until supplies run out at the office located at 400 Rockaway Avenue. If you are in need of support, please stop by for provisions. Additionally, on March 19th, the Councilwoman will be hosting a community advisory meeting on NYCHA and efforts to privatize certain developments. Additional information will be forthcoming.

**Ms. Sarana Purcell, District Leader** for the 43rd Assembly District, brought greetings to the community along with a few announcements. She stated that there are a number of important things happening in the community, most notably changes to district lines due to redistricting, and an upcoming special election for the 43rd Assembly District. She explained that those in the 43rd district will vote based on current lines in the special election, but in June, for the regular primary, everyone citywide will vote according to their new lines. As part of redistricting, election districts have changed, meaning that your poll site might have changed as well. For the most accurate and up to date information, make sure to visit the Board of Elections website to determine your new elected officials, who to vote for, and where to vote.

**Mr. Malcolm McDaniel** from the Mayor office, announced that he left Borough Hall with Mayor Adams and joined his staff at the Mayor's Office. He provided a synopsis of a few of the events recently held by the Mayor's Office, as well as a few of the upcoming events later in the month. If you are hosting an event and would like Mayor Adams to appear, email invitethemayor@cityhall.nyc.gov. If you have a

**Ms. Karen Chambers** from the Kings County District Attorney's office announced that the DA's office has a year-round program for students to be able to get an inside look at various careers within the DA's office. The next cohort of high school internships begins in April and will run through June. To apply, visit http://www.brooklynda.org/.

Chairperson Weatherspoon thanked the elected officials present as well as all representatives for their information, and invited Dr. Raymond Codrington, President and CEO of Weeksville Heritage Center, to provide an update on programs and services at Weeksville.

## Weeksville Heritage Center – Dr. Raymond Codrington, President and CEO

Dr. Codrington announced that he is coming upon his one year anniversary as President and CEO of Weeksville, and stated that he is pleased to formally introduce himself to the community.

He stated that Weeksville was the second largest free black community in the Pre-Civil War era. In fact, passersby might see the original houses from Bergen Street and Buffalo Avenue, the ones not part of the museum, as the remnants of the era. The homes, originally built in 1836, are the original houses our ancestors lived in.

Dr. Codrington informed the Board that Weeksville, like a number of other public institutions, is becoming more open and available for tours and visitation. Tour educators are available to give the history of Weeksville during site walk-throughs. You can schedule individual or group tours, but both must be done in advance to book the tour safely and maintain commonsense level precautions.

Over the last several months, the site was a location for many different Covid-19 related activities. They served as a rapid testing and vaccination site and are currently a distributor of free covid home tests. There are several thousand left, so if you are in need of home testing kits, please stop by to grab a few. The museum is open Tuesday thru Saturday.

Performances will resume on March 19th. So far, most of the programming will be outdoors as much as possible to maintain safety. A recent exhibit opened that examines the role of Weeksville in the Abolitionist movement, that also looks at Weeksville in terms of anti-racism. Other upcoming events include virtual Financial Literacy and Home Ownership workshops. Information can be found by visiting our website at www.Weeksvillesociety.org.

Starting on June 19th, which is Juneteenth, the Weeksville Green Market will be in effect. The Green Market is a way for residents to obtain reduced rate food and greens, as well as a way for the organization to address food injustice in the neighborhood and encourage residents to eat healthier.

Dr. Codrington concluded that he and other staff are always willing to open dialogue for future programming ideas. He encouraged everyone to consider Weeksville as an oasis in the neighborhood where you can ground and center yourself, connect with the ancestors, and even enjoy open space and greenery.

Chairperson Weatherspoon thanked Dr. Codrington for the information and stated that she looks forward to working with him in the future. She then opened the public hearing on the Agency Responses to the Capital and Expense Budget.

### **Public Hearing**

Ms. Weatherspoon called to order the Public Hearing to gather comments on the agency responses to the FY 2023 Capital and Expense Budget requests. She then asked Ms. Nizjoni Granville, Ms. Gail Branch-Muhammad and Mr. Drew Gabriel to read the requests and agency responses. Chairperson Weatherspoon asked that everyone hold their comments to the end. When making comments please indicate if the item is capital or expense and include the priority number. Comments were limited to three minutes each. After opening the floor to public comments.

Ms. Weatherspoon stated that additional comments can be emailed to the district office by tomorrow no later than 12 noon.

Ms. Marquis asked where the dog run would be located in Brower Park. Ms. Andrews replied that the location would be determined by the parks department and it will be based on square footage.

Ms. Ortiz-Joyner asked about capital item #11-Lighting in Brower Park, she noticed that this is currently an item that is listed in the 36<sup>th</sup> participatory budget, who would install and how is it funded. Ms. George replied that these projects are usually funding by the local councilmember and/or the borough president and the Parks Department would either do the work or contract it out.

Mr. Saunders made a motion, that the full send a letter to the Mayor and other elected officials on the comments gathered regarding the agency responses. The motion was seconded by Mr. Raji and carried unanimously with a vote of 33 in favor, none against and zero abstentions.

Chairperson Weatherspoon thanked everyone for their comments and continued with the public hearing on committee action items.

#### **Land Use** – Sharon Wedderburn, Chair

The Land Use Committee met virtually on Thursday, March 3, 2022 via WebEx. In addition to the Chair, Sharon Wedderburn, present were: Pierre Albert, Andrew Wright, Helen Beichel, Mimi Mitchell, Cathy Iselin, Ethel Tyus, Deborah Young, Fior Ortiz-Joyner, Elaine Weinstein, Frances Langley, Irsa Weatherspoon, Gib Veconi, Jack Robinson, Jay Jaffa, Jack Ackerman, Jennifer Jordan, Xeerxeema Jordan, Kaja Kuehl, Kim Robinson, Lisa Atkinson, Kwasi Mensah, Mikayla Marquis, Princess Benn-James, Michelle George, Nix Laemmle, Karen Gray, Robert Puca, Sara Lazur, Tehila Chakansky, Mark Thurton and five callers.

The committee discussed Landmarks Preservation Commission (LPC) application for 1118 Park Place, Docket LPC-22-00721. The application is for changes to the existing garage façade from wood to a black aluminum frame with glass doors and a stucco finish.

A full presentation by Jack Jaffa and Associates Real Estate Consultants was made, followed by extensive comments and questions from the Park Place Improvement Block Association, community residents, and committee members. Mr. Veconi made a motion that the Land Use Committee withhold support of the application on the grounds that the application is not appropriate with respect to either use or design based on the following reasons that LPC would consider:

• The plan fails to match the proposed finish of the altered façade to that of the

- adjoining residential building to which the garage is an accessory;
- The garage doors will be replaced by four glass windows and two glass doors, the surrounding wall will be stucco with no attempt to match the cast stone finish of the adjoining portion of the residential building.

Ms. Young seconded the motion, which carried with a final tally of 19 in favor and one abstention. The committee hopes the full Board supports its recommendation.

Chairperson Weatherspoon asked if there were any comments or questions from the community. Ms. Beichel, President of the Park Place Improvement Block Association outlined several concerns from her neighbors regarding the renovation of this garage. She disputed the address stating that the correct address should be 1114 Park Place. She stated that because of this confusion, it causes problems with researching their permit filings. Ms. Weatherspoon stated that we have checked with the Department of Buildings and 1118 is the correct address for the garage. She also stated that the Brooklyn Topographical Bureau at the Borough President's office is charged with assigning new and/or additional addresses to existing buildings and the garage has been assigned 1118 Park Place. The Block Association also has issues with the materials being used for the renovation. Mr. Ackerman replied by stating that they are working with LPC on the proper material to be used during the renovation. Ms. Beichel also submitted a petition from area residents opposing the project which details several other concerns.

Ms. Weatherspoon then asked for any comments or questions from the community board members. Hearing none, Ms. Weatherspoon asked for a motion. Ms. Lazur made a motion that the full board support the committee's recommendation as presented to withhold support. The motion was seconded by Ms. Tyus and carried with a vote of 34 in favor, none against and no abstentions.

The next meeting of the Land Use Committee will be held on Thursday, April 7, 2022. All are welcomed to attend.

They also discussed local law 152 which requires the periodic inspection of gas piping systems of all buildings at least once every four years. For multifamily properties, this includes exposed gas piping outside and inside the building, in boiler rooms, in all amenity and common spaces, rooftop mechanical spaces and publicly-accessible areas. Several homeowners are upset that they are being inundated with letters from plumbers saying that this is urgent and must be done now. She stated that she has learned that this is not an urgent need. Homeowners should do their homework and find out their property requires this type of inspection. The committee will also inquire with the Department of Consumer Affairs about this type of literature being sent out to residents.

Ms. Granville also mentioned that there will be a special meeting joint meeting with the Land Use Committee to have a Neighborhood Planning Discussion with Tom Agnotti on March 23<sup>rd</sup>. Mr. Angotti is a Professor of Urban Affairs and Planning at Hunter College and the Graduate Center, City University of New York, and Director of the Hunter College Center for Community Planning and Development.

Mr. Myer reported that 964 Park Place tenant eviction has stopped. Old owner has to work on getting back deed for the building.

The Urban Market graffiti has been painted over. Hoping to get art work on the wall.

The Nostrand Ave commercial corridor is starting to pick back up with foot traffic.

E-bikers and E-scooters riding on the sidewalk is a danger. Can traffic enforcement be done to stop the E-bikers and E-scooters on the sidewalks. Officer Vidal stated that the 77th Pct has spoken to the restaurant owners in the area and asked them not to have their delivery people ride on the sidewalk. But most of the deliveries are done via Doordash and Uber Eats delivery employees. The restaurant owners have no control over them.

A committee member asked if the NYPD can do a PSA for do not ride E-bikes on the sidewalk. Officer Vidal, NYPD do not do PSA related to E-bikes on the sidewalk. Recommend to contact Doordash and Uber Eats and your City Council representatives.

Mr. Thurton asked if traffic enforcement has increased in the 77th Pct. Lt Polanco, traffic enforcement has not increased. A little less traffic tickets issued this year compared to last year. 77th Precinct have been issuing tickets for texting and driving.

Ms. Atkinson inquired about the lack of visible police presence at the night in the areas of Bergen, Rochester Ave, Atlantic Ave & Utica Ave. Lt Polanco responded that there are several police officers in the area.

The committee discussed unmarked and marked police cars. What are their responsibilities. They were told that NYPD: Marked cards are responding to 911 calls and unmarked cars are part of the special unit focusing on crime.
