Chairperson Weatherspoon invited elected officials and their representatives to provide updates on their respective offices upcoming community events.

Chairperson Weatherspoon called the Public Hearing on board Action Items to order:

Vice Chair of SLAC Robert Witherwax presented an omnibus of actions taken by the SLAC and Land Use committees while the full board was on summer hiatus.

Ratification of Actions at the July SLAC and August Land Use meetings

Community Board 8's By-Laws permit the Land Use and SLA and Sidewalk Café Review Committees executive authority to meet and speak on behalf of the full Board during the summer hiatus. The following items were voted on at the July 24, 2023 SLAC meeting and the August 3, 2023 Land Use meeting:

- 1. New Liquor License application for Ai Ueyo Inc., 847 Sterling Place (Nostrand/Rogers) Beer/wine/cider license (recorded music, sidewalk café, open restaurant seating) restaurant. The committee voted to support the application as presented.
- 2. Renewal liquor license application for Kinanm, 856 Atlantic Avenue (Vanderbilt/Underhill) Full license (DJ, patio/deck) Bar/Tavern. The committee voted to support the renewal application.
- 3. LPC Application for a Certificate of Appropriateness for 1235 Dean Street. Details of the application include a vertical extension with setback to reduce visibility from street; an addition of a stair bulkhead; and front and back roof decks. The application was supported as presented because of the fact that additions are not visible from Dean Street and also because the potential for more exceptions like the one presented in this application are not that great.

Chairperson Weatherspoon asked for any questions or comments from the community. Mr. Staton asked if the board had to vote on each item individually. Ms. George reminded the members that the Board's bylaws permit these committees to continue operation through the summer months due to the time sensitive nature of the applications considered, and that it is customary for all such items to be considered as one slate.

Ms. Brown-Henry made a motion to support the committees' recommendations, Meredith Staton seconded. The item passed with 27 in favor, none against and no abstentions.

Chairperson Weatherspoon called next on Committee Chairs to provide reports on their proceedings in the prior month's meetings.

- Committee needs greater community involvement and participation as it is a very important committee
- Env/San/Trans Chair Robert Witherwax presented the following details for the EST meeting held on September 22nd and attended by Edward Delman, Karen Gray, Alan Gerber, Saskia Haegens, Delores Hutchinson, Jennifer Jordan, Xeerxeema Jordan, Peter Krashes, Frances Langley, Bobby LaPointe, Lisa Moldanado, William Meehan, Celeste Stern, Mark Thurton, Robert Witherwax, Deborah Young, and several community residents.
 - Discussed budget items & Community Goals
 - Next meeting is October 24th, considering a street co-naming in honor of Elsie Richardson
 - Announcement about properties with >10 units moving to containerized trash in 2026, and then properties <10 units moving towards autoloaders. Will be further discussed in committee as a few issues have been identified including:
 - DSNY has not designed the containers yet.
 - 90,000 cars are expected to be removed from the street.
 - Rat proof garbage cans sponsored by BIDs are appearing in Brooklyn Heights.

- Housing No committee report was submitted; however, Chair Nizjoni Granville presented the following:
 - Reviewed the City of Yes document, disappointment in how little detail was included
 - Land Use also discussed the presentation.
- Land Use No committee report was submitted; however, member Gib Veconi presented the committee report in absence of the committee chair:
 - Discussed City of Yes, several components which were of interest, including the following:
 - 20% additional floor area for housing under current zoning if the additional housing is affordable, but not clear how affordable the new housing would be required to be.
 - Proposal to eliminate parking minimums was of particular interest.
 - Extensive discussion of AMI and its impact on how deeply affordable the permanently affordable housing ends up being.
 - There will likely be a citywide ULURP that follows this proposal, with a modification to Mandatory Inclusionary Housing (MIH)

 - Traffic cameras
- Marva Brown-Henry Parks. Lighting in Brower Park, especially around basketball court
- o Brower Park Skate Park lighting.
- Protected Bike Lanes & bulbouts further emphasized by a community member
