The Pandemic has not interrupted NYC Workplace laws. There have been new amendments to the NYC Paid Safe and Sick Leave Law that will take effect in 2 Phases. The deadline to file a 2019 tax return was October 15, 2020. If you were required to file a return, NYC Free Tax Prep can assist you if you meet income requirements; however, be aware that late filing penalties and late payment penalties may apply. Eligible New Yorkers are encouraged to use these NYC Free Tax Prep services. Options include In-person Tax Prep, Drop-off Service, Virtual Tax Prep, and Assisted Self-Prep for **free**. The professional financial counselors at NYC Financial Empowerment Centers can help New Yorkers manage their bills and credit amidst the coronavirus crisis, understand student loan repayment options, and more in a confidential setting. If you are being called by Debt Collectors, please note that DWCP has created a joint letter template that you can fill out and mail (required by federal law) so debt collectors cannot contact you until the State of Emergency in New York City has ended. The New York Forward Loan Fund (NYFLF) was created to address the capital needs of New York's small business owners, nonprofits, and small landlords created by the COVID-19 economic crisis. The Governor's Office launched this Fund with The Community Preservation Corporation (CPC) as its Small Landlord CDFI Partner. Building owners experiencing reduced cash flow due to tenants impacted by COVID-19 may apply for NYFLF loans with assistance from CPC and local CDFI partners. Under the program, the loan size is flexible to maximize the volume of small-dollar loans to meet the unique financial needs of small rental buildings. The maximum loan size available under the program is \$100,000, with no limit on the minimum amount.

Eligible properties include:

- · Small property owner with no more than 200 units under ownership
- · No single property greater than 50 units
- Properties must be located in a Community Reinvestment Act ("CRA") eligible census tract or meet a rent test where the property rents are affordable to tenants at, or below, 100% AMI

UPDATE FROM CONGRESSWOMAN YVETTE CLARKE'S OFFICE

Congresswoman Yvette Clarke is pleased to announce legislation she recently co-sponsored to amend the National Voter Registration Act of 1993 to treat the lease for a dwelling unit under certain federally assisted housing programs as a simultaneous application for voter registration in elections for Federal office, to designate owners of dwelling units under certain federally assisted housing programs as voter registration agencies for purposes of such Act, and for other purposes.

## **WINTER SERVICES FOR SENIORS**

Seniors living in Bed-Stuy and Crown Heights might be eligible for upcoming services through a "Naturally Occurring Retirement Community" (NORC) set up by Councilman Robert Cornegy. Those 60 years and older who live in the 36<sup>th</sup> Council District 36 can take part in the "NORC," a designation that lets seniors stay in their homes while accessing a host of city-funded services, like healthcare, classes or outings.

The NORC, set up with the help of Brooklyn Neighborhood Services, released its schedule for the winter season, including a series of webinars focused on generational wealth retention, financial literacy and help accessing online services like personal shopping assistance, emergency home repair grants and home maintenance assistance,
