The City of New York will host an official Day of Remembrance on Sunday, March 14, 2021 at 7:45 p.m, and you are invited to join the program online to honor the family, friends, frontline and essential workers, and above all else our fellow New Yorkers. All New Yorkers are invited to tune in and share the name and photograph of a person they lost. The photograph may be featured as part of the City's ceremony.

The photo should be a clear image of your loved one pictured alone (not in a group or a family photo); showing them from their chest up to the top of their head; in the highest resolution possible; if taken on a mobile phone, just export or share in its "original" or "full size" format.

# **INDOOR DINING RETURNS AT 50%!**

After an extended break, indoor dining has returned to New York City restaurants with 50% capacity. While there are still restrictions in place on capacity, it is a step in the right direction for dining "normalcy." Furthermore, more and more recreational locations and venues are opening for use, including movie theaters, billiards and comedy halls, and even smaller live music venues. Sports fans have greater reason to rejoice as larger capacity venues are allowing in greater numbers of fans.

As always, we ask that should you desire to participate in live events, do so mindfully and safely, adhering to common sense notions such as staying home if you are feeling unwell, keeping your mask on, and continuing to socially distance.

Testing saves lives and reduces unnecessary risks. If you desire to partake in the re-opening world, get Covid tested often at any of new York City's Health and Hospitals locations, which include every government funded hospital, all Dept. of Health medical clinics, and even pop up sites throughout the city. Most urgent care centers also offer testing, but you may be required to pay a copay.

#### **COVID-19 VACCINATIONS**

Covid-19 vaccines are available to all New Yorkers age 65 and older. Please call (877) 829-4692 (877-VAX-4NYC) and give your zip code for a location and date for your vaccination shot. This service is provided by NYC Health and Hospitals Corporation.

Additionally, pharmacies are also beginning to receive the vaccine for distribution to the public. Walgreens is now offering the Covid-19 vaccine locally and you can search for an appointment directly on their website. You will need to first create a Walgreens account and then search for Covid-19 vaccine and follow prompts.

Residents aged 65+ unable to travel for their vaccine are eligible for free vaccine transportation services to and from City vaccination sites with Curb-powered taxi services.

Call (877) 829-4692 (877-VAX-4NYC) to make an appointment at a City-operated vaccination site. After making an appointment to get vaccinated, participants will be screened and directed to Curb's 24/7 call center to book their trips, Access-a-Ride, or ambulette services as appropriate.

FREE PPP & FORGIVABLE LOANS PROGRAM ENDS MARCH 31ST!

The Paycheck Protection Program (PPP) provides loans to help businesses keep their workforce employed during the COVID-19 pandemic. Borrowers may be eligible for PPP loan forgiveness. The Brooklyn Chamber of Commerce (BCC) announced that the Paycheck Protection Program (PPP) no longer requires businesses to have employees in order to qualify for their loan program. The loans are forgivable, but the program will close March 31st. Further, the BCC will provide legal help to form merchant associations.

ACCESSIBLE DISPATCH TAXI SERVICES

Accessible Dispatch is helping NYC residents and visitors with disabilities access the city like never before. Accessible Dispatch gives individuals with disabilities the ability to request a wheelchair accessible taxi from anywhere in New York City. Service is available 24 hours a day, seven days a week in all five boroughs. There is never an additional fee for passengers to use this service as passengers pay only the standard metered fare set by the Taxi and Limousine Commission (TLC).

#### NYC FREE TAX PREP

If you earned \$68,000 or less in 2020, you can file your taxes for free with the help of an IRS certified VITA/TCE volunteer preparer. Preparers can help you file your taxes safely now and transmit the returns to the IRS when they open the tax season on Friday, February 12, 2021. You can file safely from the comfort of your home or in person.

Services are available in English, Spanish, Arabic, Bengali, Chinese, French, Haitian Creole, Korean, and Russian. Additional languages are available through phone interpretation.

PROPERTY TAX EXEMPTIONS

It is now easier than ever to apply for property tax exemptions! The City of New York offers property tax exemptions for seniors, veterans, clergy members, people with disabilities, and other select homeowners. These benefits can reduce property taxes by up to 50% and save homeowners thousands of dollars each year.

Income limits for seniors and persons with disabilities (SCHE and DHE) is \$58,399. Additionally, the STAR program is available to homeowners with annual salaries less than \$500,000 (must apply with the state), and Enhanced STAR is available for seniors 65 and older with annual incomes of \$90,550 or less.

Those that serves in the US military during designated periods of conflict, their un-remarried surviving spouses, and Gold Star parents are eligible for tax exemptions. Additionally, active and retired members of the clergy or their un-remarried surviving spouses can receive tax exemptions.

For more information or to apply, call 311 or visit www.nyc.gov/contactdof. The deadline to apply is March 15, 2021, and if approved, your tax exemptions will begin on July 1st. You can also apply online directly, or renew if you currently receive the tax exemptions, at www.nyc.gov/dofsmartfile.

VACCINE FOR ALL CORPS JOBS

In his recent State of the City address, Mayor de Blasio announced the Vaccine for All Corps, an effort to bring good jobs to 2,000 New Yorkers supporting vaccination efforts across the five boroughs. Hiring for the first of these positions is now live at www.nyc.gov/vaccinejobs.

Recruitment for Vaccine for All Corps jobs is led by the Workforce1 Career Center System operated by the NYC Department of Small Business Services (SBS), targeting candidates from the communities hit hardest by COVID-19. No healthcare experience is required for many of these positions, which include roles in site management, operations, and client services, in addition to clinical roles. Interested jobseekers should visit www.nyc.gov/vaccinejobs to fill out an interest form to begin the screening process with SBS Workforce1 staff.
