ST. JOHN'S RECREATION CENTER

The New York City Parks Department has a major and much needed contract for heating, ventilation and air conditioning (HVAC) for St. Johns Recreation Center located at 1251 Prospect Place (between Troy and Schenectady Avenues), Brooklyn. The center will be closed from May 21, 2018 to October 2018 due to these much needed renovations.

The Parks Department has elected to close the center for this time to complete the renovations as quickly as possible with as few interruptions in services as necessary. In place of the recreation center, recreational programming will be offered in St. John's Park (directly next to and behind the center) five days a week as weather permits, and members of St. John's Rec will have their memberships honored free of charge at any other recreation center in Brooklyn.

The scorecard rating for the month of April was 78.8% for streets and 91.7% for sidewalks. We urge everyone to adhere to the Dept. of Sanitation's residential enforcement routing times of 8 AM to 9 AM and 6 PM to 7 PM daily. Please clean in front of your properties and 18 inches into

the gutter area of the street. All sweepings must be bagged and disposed of properly. Thank you for your assistance in helping to keep the District clean.

MAY IS MENTAL HEALTH AWARENESS MONTH

May is Mental Health Awareness Month. As the stigma of mental illness continues to plague our city, it is imperative that dialogue on the issue is continued to raise awareness. Too often, mental illness is disregarded as a "fake" sickness, and the appropriate course of action is for someone to "pull themselves up by the bootstraps." This is an incorrect approach to the subject.

Mental illness is more than just depression, and depression is more than a prolonged feeling of sadness. In fact, depression can manifest itself in many forms. For instance, anger, sadness, isolation, a feeling of emptiness or hopelessness, acting outside of your normal character (taking risks of various kinds, ceasing participation in actions that normally bring you joy, etc.) listlessness, forgetfulness, and many more are all manifestations of depression. Bi-polar disorder, anxiety, seasonal affective disorder, borderline personality disorder, schizophrenia, and many more are all aligned under the broader spectrum of mental illness.

First Lady of NYC, Chirlane McCray, has advanced the THRIVE NYC program, whose purpose is to champion mental illness awareness, eliminate the stigma, and provide help to those that need it when they need it. For so long, New York City has not done enough to support the emotional wellbeing of its residents. Too many New Yorkers have not gotten the help they needed for any number of reasons. THRIVE NYC's website states that 41% of adult New Yorkers with a serious mental illness said they needed treatment at some point in the past year but did not receive it or delayed getting it for myriad reasons including but not limited to, fear of the stigma, not thinking it could help, an inability to afford services, and not knowing where to receive services. This delay in care impedes progress and also heightens conditions, making their impact on the affected person worse.

If you or someone you know is possibly suffering from mental illness, please seek help as soon as possible. Do not delay. Utilize the provided you. NYC WELL is available 24 hours a day, 7 days a week. Someone is always available to talk and help you through your issues.

THRIVE NYC also is hosting a mental health training in collaboration with Assemblywoman Diana Richardson on **Saturday**, **May 12, 2018** at Kings County Hospital in the T Building Auditorium, 689 New York Avenue, Brooklyn from 9:00AM - 5:00PM.

During this free 8 hour training session, participants will learn how to identify signs and symptoms of anxiety, depression and other mental illnesses. If you are interested in participating, RSVP at http://crownheights.timetap.com.

BROWER PARK LIBRARY UPDATE

Great news! The partnership to relocate Brooklyn Public Library (BPL) Brower Park Branch into the Brooklyn Children's Museum received \$3.3 million in the FY 18 City Budget.

The Brooklyn Children's Museum successfully raised funding that will pay for the design and build-out of the new library. In October the Department of Cultural Affairs put out a news release announcing the partnership, and detailed the funds that were allocated in the city budget.

The funds came from:

- Mayor de Blasio/Department of Cultural Affairs: \$2,500,000
- Brooklyn Borough President Eric Adams: \$500,000
- Councilman Robert Cornegy, Jr: \$300,000

BPL put out a request for proposal (RFP) for an architect to design the space and the Brooklyn firm TsAO & McKown was selected. Despite the agency being in the early stage of gathering information, they have vowed to be fully transparent in the process and include the community in a discussion about what patrons would like to see in the library.

The Library and the Museum, along with the architects, anticipate holding the first

community engagement session in mid to late June (date and location to be determined). As soon as a date and location has been determined, it will be shared with the community. There will be several opportunities and different ways to give your feedback.

BPL will continue to operate in the current leased space at 725 St. Marks Avenue until the new library opens. The anticipated construction on the new space is mid-2019 and lasting approximately 1 year to mid-2020.

DID YOU KNOW? SIDEWALK OBSTRUCTION EDITION

According to the NYC Dept. of Transportation, sidewalk areas must be kept free from any obstruction that could impede pedestrian traffic. Obstructions may include but are not limited to, refuse, refuse containers, merchandise, bins, racks, coin-operated rides, sandwich or A-frame signs, over-extended sidewalk displays/stands, ATMs, ice machines, and acrylic enclosures, etc.

Stores are permitted to have outside displays of merchandise. The items displayed must consist of goods which are available for sale inside the store and all sales must occur inside the premises. Structures for merchandise displayed outside the store may extend no more than 3 feet into the sidewalk from the building line and no higher than 5 feet tall. However, streets that are designated "zero sidewalk display streets" may not have any displays placed on the sidewalks. To find out if a particular street is a "zero sidewalk display street," please call 311. (Excerpt from §16-118(2)(a))

LAUNCH OF THE LONG TERM CARE PLANNING COUNCIL

In Governor Andrew Cuomo's 2018 State of the State Address, he announced the launch of a Long Term Care Planning Council to prepare for the emerging needs of New York State's growing aging population. The charge of the Council is to examine New York's long term care system. Specifically, the Council will:

- Analyze, evaluate, and identify the existing service gaps in New York's long term care system;
- Determine the most cost-effective evidencebased interventions; and
- Prepare a strategic plan to meet the emerging needs of New York's aging population over the next decade.
