#### **HEAT SEASON**

October 1, 2016 marked the first day of heat season in NYC. The Dept. of Housing, Preservation, and Development has strict minimum heat guidelines that all landlords must follow.

From now until May 31, 2017, between the hours of 6:00 AM and 10:00 PM, if the outside temperature falls below 55 degrees, the inside temperature is required to be at least 68 degrees Fahrenheit. Between the hours of 10:00 PM and 6:00 AM, if the temperature outside falls below 40 degrees, the inside temperature is required to be at least 55 degrees Fahrenheit. Any landlord that fails to adhere to these guidelines should be reported to HPD via 311 immediately.

## IS CHAPTER 7 BANKRUPTCY THE RIGHT OPTION FOR YOU?

Upsolve is a Brooklyn-based nonprofit that helps low-income New Yorkers file for Chapter 7 bankruptcy for free.

Bankruptcy is a legal process that erases all of your medical and credit card debt. It also erases any debt you have from civil judgements against you. If your wages are being garnished because you owe a creditor, bankruptcy could stop the garnishments. Please note that bankruptcy does not erase student loan debt and may or may not erase back taxes you owe. It also does not erase any alimony or child support that you owe.

If you have over \$10,000 in debt that you do not think you will ever be able to pay back and your credit score is less than 600, you are probably a good candidate for bankruptcy. Since your credit score is already low, bankruptcy is unlikely to have a significant effect on your ability to access credit and may even improve your ability to access credit.

Bankruptcy provides a fresh start and you won't have to worry about paying your creditors. It will also eliminate harassing phone calls you receive to pay your creditors. If you have the type of debt that can be erased, filing for bankruptcy will mean that money you earn will now go to your pocket rather than paying creditors.

If you have less than a 600 credit score and over \$10,000 in debt, your ability to access credit may improve after filing for bankruptcy. Creditors may be more willing to give you money because they know you don't have to pay anyone else back.

- Over \$10,000 in credit card or medical debts, or civil judgements
- Less than 600 credit score (or right around 600)
- Hasn't filed bankruptcy in the last 8 years
- Doesn't own a house or apartment

- Earns less than:
  - o \$49,086 for a one-person household
  - ○\$62,451 for a two-person household
  - ○\$72,074 for a three-person household
  - o \$88,747 for a four-person household
- Currently not operating a business
- Doesn't owe back rent on current house/apartment



#### TAX LIEN REFORM MAY OFFER A SOLUTION TO CROWN HEIGHTS AFFORDABLE HOUSING CRISIS

On October 3, an article appeared in the Guardian, a respected British newspaper, written by Megan Carpentier. The title read: "The last battle for Brooklyn, America's most unaffordable place to buy a home. It might be too late for Williamsburg, Bushwick and Bed-Stuy – but in Crown Heights, tenants have learned a few tricks to prevent the social cleansing of their



neighbourhood. Can they succeed where the rest of Brooklyn failed?"

Because of historic redlining, banks would not lend in Crown Heights or Bedford-Stuyvesant for decades. Much of the housing stock was largely neglected for 40-50 years. Because of this neglect, many of apartments need extensive renovation to meet modern building codes or to just be nice places to live. Nothing will change unless we develop a process to protect distressed properties in our neighborhoods from unaffordable renovations.

Perhaps one answer lies in reforming the tax lien sales conducted by the Department of Finance. Since 1996, the City has relied on such sales to collect delinquent taxes. Under this program, the rights to collect delinquent taxes are sold in blocks to wealthy for-profit investors who are also allowed to collect penalties and interest from the owners of the property. Eventually these investors can use foreclosures to take ownership of the properties.

Now both Public Advocate Tish James and Comptroller Scott Stringer are promoting plans to remove certain properties from the tax lien sales. Under PA James' plan, which is the better of the two in my opinion, a special non-profit preservation trust would be created to collect taxes on properties that were deemed distressed. This new Citycontrolled non-profit group would have an affordable housing mission unlike the current system where the lien holders are for-profits. Her plan would also expand the

definition of distressed properties to include a wider range of properties.

Comptroller Stringer wants to revert to the older system used prior to 1996, where the City took title directly to properties with delinquent taxes.

Both plans at least offer a solution to a problem that has made Crown Heights a punching bag for housing critics worldwide. Mayor DeBlasio's response: "We have found that the lien sale program is an effective tool to collect delinquent municipal charges," said Mayoral Spokeswoman Freddi Goldstein, adding, "HPD removes distressed properties from the lien sale where it can use its affordable housing programs, and will continue to look at how all available tools can be used to create affordable housing."
