Please review checklist of acceptable documentation that should be brought to the enrollment session. All applicants must submit *copies* of requested documentation to receive full consideration. Please provide <u>1</u> document from each section.

## INCOME:

- Federal 1040/1040A/1040EZ Tax Return (2017)
- Documentation from county department of social services (e.g. HRA Budget letter, Children Services)
- Unemployment or worker's compensation
- Supplemental Security Income (SSI) or Social Security Benefits print out
- IRS Form 4506-NON-FILERS

W-2 Forms or paystubs are NOT ACCEPTABLE.

# **IDENTIFICATION:**

- New York State Driver's License or Non-Driver's ID<sup>1</sup>
- New York State Benefit Card with Photo
- New York City ID Card (plus copy of Birth Certificate)
- Permanent Resident Card<sup>2</sup>
- US Passport

#### **IMPORTANT:**

<sup>1</sup>A **New York State Driver's License or Non-Driver's ID** serves as Identification and New York State Residency

<sup>2</sup>All **permanent residents** must submit a copy of Permanent Resident Card

## **EDUCATION:**

- High School Diploma (HSD) or Official HS Transcript
- GED Diploma or HSE Diploma or GED/TASC Transcript
- Letter from high school verifying graduation date. Must be in sealed envelope on school letterhead.

## **COLLEGE PREP APPLICANTS ONLY!**

- HSD or GED and CUNY Placement Test Scores or
- Academic dismissal letter from a College or University & CUNY Placement Test Scores

## **NEW YORK STATE RESIDENCY:**

- · New York State Motor Vehicle registration card
- Proof of ownership of New York State real property
- · Lease for property in New York State
- New York State Tax Return (2017)

## \*\*\*IMPORTANT NOTES\*\*\*

- Married applicants must provide income information for them self and spouse.
- Applicants under 22 years of age must show proof of support from parents, if they cannot demonstrate self-sufficiency.
- Proof of education is recommended but not required for ESL, HSE, Security Guard or OSHA programs
- Current resume is strongly recommended for all career, OSHA and Security Guard applicants.
- Security Guard applicants must have ability to pass background check
