## **Saw Cutting**

On/about Tuesday, May 12<sup>th</sup>, 2020, the NYC Department of Design and Construction (DDC) is scheduled to begin saw cutting for the installation of Green Infrastructure Infiltration Basins at various locations. To facilitate this activity, parking restrictions will be in effect. **"No Parking"** signs will be posted for the duration of these activities. Driveway access may be temporarily interrupted in order to complete construction in a safe manner.

### Work will be performed at various locations as listed:

- St Andrews Place between Herkimer and Atlantic Avenue
- 1534 Atlantic Avenue
- 1446 1442 Pacific Street
- 1447 Pacific Street
- 1425 Pacific Street
- 1369 Pacific Street

#### Community Impacts:

- Temporary elimination of curbside parking and restrictions to driveway access.
- The NYCDDC will monitor operations and work within the DEP Noise Code regulations.
- Emergency vehicle and pedestrian access will be maintained at all times.
- Full access to driveways and street parking will be restored when construction activities are completed on each block.
- Signs will be posted in the affected areas.
